### Oath of Office

Board of Regents' Chairman, Mr. W. Clinton Rasberry, opened with a note regarding the Original Oaths of Office forms for the WISE Council that were distributed and asked to have the forms signed and returned by the end of the meeting. He further informed the Council that the meeting was open to the public and was being videoed for Board of Regents records.

### Organizational Matters

Mr. W. Clinton Rasberry reminded the Council of their responsibility under Act No. 803. The WISE Council shall function as an independent subcommittee of the Board of Regents and is responsible for the implementation of the WISE Fund, subject to Board of Regents approval.

### Discussion of CDBG Fund Procedure

Ms. Barbara Goodson discussed the eligible and ineligible expenses regarding the Program Income Funds from the Gustav and Ike hurricanes. She further stated that the funds must be spent in the same way the Gustav and Ike funds were approved. She noted that although the money was budgeted for one year, the Board of Regents has the option of signing up for a three year agreement. Ms. Goodson stated that the funds will flow through the Board of Regents. The Board of Regents will be held responsible for all audits, accountability functions and the disbursement of funds to each system.

Ms. Goodson stated that there are three types of funding for WISE: General Funds, CDBG Funds (which have limitations) and funds in HB 2 which are tied to construction and acquisition type purchases. The WISE Council must develop a plan that meets the parameters of how funds can be used following those guidelines.

### Schedule of Future Meetings

The Council is set to meet again in early August, where Mr. Rasberry hopes to move forward with a clear plan for the allocation of funds. He also stated that it is essential for all WISE Council members to be present at the next meeting to assure that everyone is on the same page. Under the law, the WISE Council shall meet no less than two times per year.

## Other Business

### A. America Works: Education and Training for Tomorrow's Jobs

Ms. Goodson stated that the American Works Initiative is aligned with the WISE initiative. The grant application of \$170,000 is for training that is coordinated by The Workforce Commission and must be signed by the Governor's Office, LED, Workforce Innovations, Higher Ed and K-12. The proposal is due July 2, and Dr. Lisa Vosper will be the lead on this project.

## Adjournment

There being no further business to come before the WISE Council, the meeting was adjourned at 1:35 p.m.
